2. Description of changes


- ① All of the target products: The CE will be marked on the batteries.
- ② NP8P-BT3 : It will be changed about the capacity of the battery aside from that mark the CE on the batteries.


Please make sure section 4 for the details of the changes. There are no changes in the specification of the batteries except for NP8P-BT3.
